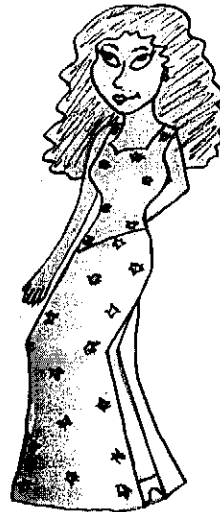
I USE MY *'Yiddisha Kusp'*

MAJORED IN THEATRE, NOT IN ACCOUNTING!)



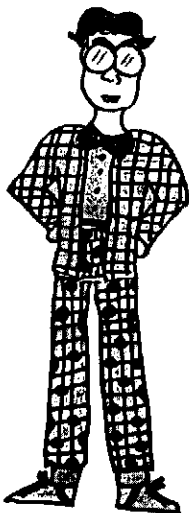

CREATES THE IMPRESSION THAT SOMEONE HAS JUST LEFT.)

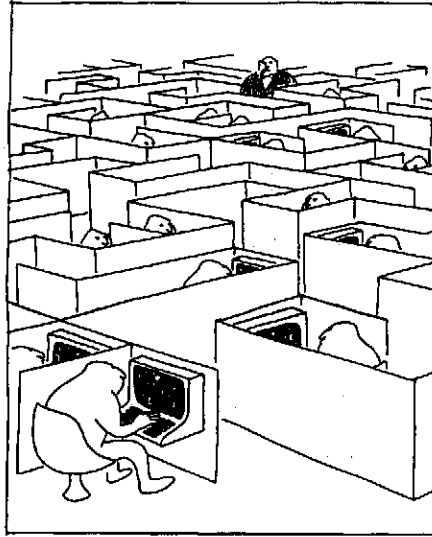
HE IS EMPOWERED BY AN ORGANIZATION THAT IS INNATELY
